PRODUCT DESCRIPTION

HIGH GLOSS WAX is a clear, durable wax that resists surface abuse when properly maintained and leaves a beautiful high gloss finish. It is heel mark, stain, and abrasion resistant. HIGH GLOSS WAX can be easily buffed, and is free from odors and fumes during application.

Coverage – Approx. 1,500 to 2,000 square ft. per gallon (3.785 L), depending on type and texture of surface and method of application.

APPLICATION PROCESS

Procedure – Sweep and mop floor. Remove old wax (if present). Let dry and apply HIGH GLOSS WAX with mop, sponge, cloth, or by mechanical means. Apply second coat in heavy traffic areas or where needed. Allow 30 minutes intervals between coats.

Repeated coats will produce a very durable, high gloss finish. Product can be removed by using a wax stripper.

HIGH GLOSS WAX can be used on sealed Stamped Concrete or Chemical Stain. Also on all sealed concrete floors & slabs, terrazzo brick, Mexican tile, ceramic tile, slate, adobe, and quarry tile as well as parquet and sealed wood.

SAFETY PRECAUTIONS
