## PRODUCT DESCRIPTION:

**SPRAY GROUT** mixture is a specially formulated system for a variety of substrates, including concrete, masonry, brick, metal, and wood. Do not use on asphalt. SPRAY GROUT is specifically engineered for use with SPRAY GROUT RESIN.

#### **RECOMMENDED USES**

For use around swimming pools, patio decks, walkways, and porches. For use indoors and outdoors.

#### **NON-RECOMMENDED USES**

Not for use over existing river gravel, loose or unstable base, poor drainage areas or industrial traffic.

**Preparation:** Remove any loose material such as paint or chipped concrete. Degrease surface with **Concrete Cleaner & Degreaser** using 8-16 fl. Oz. of Cleaner & degreaser to one gallon of water. Acid wash surface with a 1 to 5 solution of Hydrochloric Acid in water. Rinse thoroughly with clean water and let dry completely.

#### **Mix Ratio**

- **1)** Reduce Spray-Grout Resin by 50%with cold water. Add 4-6 quarts of the mixed Resin water mixture to a clean 5-gallon plastic pail.
- 2) Slowly mix resin/water mixture with a paddle mixer on a half-inch drill. While slowly adding 1-50 lb. bag of Spray-Grout.

**Application:** Grout mixture can then be trowelled, squeegeed, or sprayed onto the surface not to exceed ½" in thickness.

**Seal:** After at least 24 hours drying time, the surface must be scrapped, broomed, and blown with a high velocity blower and then sealed with Clear Seal or a Concrete Stain Sealer. Please see application information pertaining to these products prior to usage.

Contains: Portland Cement. Avoid contact with eyes and prolonged contact with skin. In the event of contact, flush eyes with water immediately or wash skin with soap and water.
