## PRODUCT DESCRIPTION:

Thin-Stamp Bonding Agent is a specially designed bonding resin used for bonding Thin-Stamp overlayment onto existing concrete. It is an ASTM C-1042/1059 rated, high strength bonding agent with a high solids content for increased durability.

**Coverage** – Approximately 150 to 250 square ft. per gallon (3.785 L), depending on type and texture of surface and method of application.

Contains: RESIN EMULSIONS. Avoid contact with eyes and prolonged contact with skin. In the event of contact, flush eyes with water immediately or wash skin with soap and water.

### **Preparation:**

Remove any loose material such as paint or chipped concrete. Degrease surface with **Concrete Cleaner & Degreaser** using 8-16 fl. Oz. of Cleaner & degreaser to one gallon of water. Acid wash surface with a 1 to 5 solution of Hydrochloric Acid in water. Rinse thoroughly with clean water and let dry completely.

#### Procedure:

Apply THIN-STAMP BONDING
AGENT liberally over entire surface
with a roller, making sure not to leave
any puddled areas. Let dry before
applying overlay. Product will be tacky.
NOTE: Extremely porous surfaces will
require 2 coats, (Generally
recommended) and first coat must dry
completely before applying second
coat.
