PRODUCT DESCRIPTION:

LIQUID CLEAR RELEASE contains a specially-formulated releasing agent that forms a moisture barrier between the stamping tools and wet concrete that facilitate the release of flexible tools. It is applied directly on top of the **COLOR HARDENER** (if needed) or the **THIN-STAMP OVERLAY PRODUCT**. Preferred method is to only apply generously to the stamping tool prior to stamping. This clear liquid release agent leaves no trace or residue. For use on textured concrete only. This product has a light Bubblegum fragrance.

APPLICATION

Spray Application: Use a pump sprayer with a medium tip size and medium to low pressure. Spray the stamping tool first. Results may be fine with doing only the stamping tool. Product can be sprayed onto the decorative concrete surface, should conditions demand.

Allow product to fully dry prior to antiqueing, or sealing the decorative concrete surface.
