Product Description

Soy Stripper Wash is a specific wash compound made ex Strippers. This product will dissolve and remove Soy based Ester oils that conflict with the reapplication of sealers. *Not for use on polymer modified concrete (RE: Thin-Stamp, Overlayments, Spray-Grout, Color-Grout, etc.)*

Application Procedure –

Stripper Wash is packaged as a concentrate. Dilute with equal parts of clean water (50/50) for best results. Can be diluted 2 parts water to 1 part stripper wash for lighter applications.

Use a brush, roller, or airless (pump) sprayer to apply a uniform thin coating to the surface. Allow material to wet in for 10-30 minutes and then stiff broom or mechanically scrub the surface. This will lift out all remaining coating particles and dissolve the Soy esters that are deep into the concrete surface. Then rinse, pressure wash or clean mop the area completely and let dry. Stripper Wash is safe to use on wood, brick, stone, concrete, integral colored concrete, color hardener, metal, plaster, and many other surfaces. Do not use on plastic, PVC, rubber, dry wall, or Polymer-Modified concrete. Stripper Wash may be used indoors or outdoors.

Coverage:

Approximately 200 to 350 square ft. per gallon, depending on type and texture of surface and method of application.
